_____, henceforth known as "Client," agrees to hire **Arie Monroe**
(DRAWLIKECRAZYSTUDIOS LLC.) , henceforth known as "Caricature Artist," for a performance

Furthermore, the two parties agree to the following:

Caricature Artist will arrive 15 – 20 minutes before the event begins in order to set up. Drawing will begin at the agreed time of _____ .

Artist will draw for _____ hours. Artist will draw up to 15 minutes after the agreed to time to complete people standing in line. If for some reason the line has not been cleared withing 15 – 30 minutes after the agreed to time the client will be charged for an additional hour of work.

During the agreed time, the caricature artist will draw as many people as he/she can, averaging about 1 person ever 3 – 5 minutes in black and white. Artist will provide all drawing supplies for the event, but asks that the client provide an area with sufficient lighting, as well as, table and 3 chairs for the customers to sit and be drawn comfortably.

Client will pay artist _____ as compensation for this performance, plus the cost of travel if for some reason the event is more than 45 minutes travel time.

If long distance travel is required Client agrees to pay _____ hour to cover travel cost, as well as _____ if it is necessary for the artist to have a hotel for overnight stay.

Payment can be made via **check, money order, cash, or credit card** according to the following plan:

A non-refundable deposit in the amount of _____ is to be made to secure the agreed time and dates for the event. Payment can be sent by paypal, credit card, check, or money order.

The remaining balance in the amount of _____ will be paid during the week of the scheduled event or on the day of the event after the artist has completed the job. All credit card payments will have a 3% transaction fee.

If for some reason the Client must cancel the event, the Artist must be notified within 48 hours of the scheduled event. If the Artist is not notified within this time, a cancellation fee in the amount of 50% of the original agreed to hourly rate, must be paid to the Artist.

If for some reason the Artist must cancel, the Client will be notified immediately, and a replacement Artist will be provided in the original Artists place. If a replacement can not be secured the Client will receive full refund of deposit or any other money paid prior to the event.

The Parties recognize and agree that a person's response to caricature art, like any art, is subjective. The parties further agree that a subject's negative reaction to a caricature portrait shall not be grounds for reducing the Caricature Artist's compensation. If a person is not happy with their caricature, the Caricature Artist will re-draw it once if time permits.

This contract is enforceable according to the laws and regulations of the state of Missouri.
